**Fourth meeting of the intersessional process considering the Strategic Approach and sound management of chemicals and waste beyond 2020 (IP4)**  
Bucharest, Romania, 29 August – 2 September 2022

## **Annotations to the Provisional Agenda**

### **Item 1: Opening of the meeting**

1. The fourth meeting of the intersessional process (IP4) considering the Strategic Approach and sound management of chemicals and waste beyond 2020 will open at 10:00 a.m. on Monday, 29 August 2022.
2. A representative from the Government of Romania will open the meeting. Additional opening statements will be made by Ms. Anita Breyer, President of the fifth session of the International Conference on Chemicals Management, and Ms. Sheila Aggarwal-Khan, UNEP.
3. The meeting will be co-chaired by Ms. Judith Torres (Uruguay) and the newly appointed Co-Chair replacing Mr. David Morin (Canada) who has stepped down from his role of IP Co-Chair.

### **Item 2: Organizational matters**

#### **(a) Appointment of the IP Co-Chair**

4. In December 2021, the Government of Canada informed the Bureau that the country is no longer able to fill the role of the Co-Chair of the intersessional process, while assuring their continued commitment to a successful outcome at ICCM5 and sound management of chemicals and waste both domestically and globally.
5. On 12 April 2022, the WEOG region nominated Ms. Kay Williams from the United Kingdom as IP Co-Chair replacing Mr. David Morin from Canada. As communicated to the Bureau in advance of the 20th Bureau meeting held in March 2022, Ms. Williams will start working ad interim until an official co-chair appointment can be made at the fourth meeting of the Intersessional Process (IP4) scheduled to take place from 29 August to 2 September 2022.
6. The meeting may wish to officially confirm Ms. Kay Williams to the role of Co-Chair of the intersessional process.

#### **(b) Adoption of the agenda**

7. Participants may wish to adopt the provisional agenda as set out in meeting document SAICM/IP.4/1/Rev.1.

(c) **Organization of work**

8. The work of the meeting will be conducted in plenary sessions and possible thematic groups and informal consultations, if needed. It is proposed that plenary be held from Monday, 29 August 2022 to Friday, 2 September 2022 from 10:00 a.m. to 1:00 p.m. and 3:00 p.m. to 6:00 p.m. The draft schedule is contained in Annex 1<sup>2</sup>.

9. As set out in International Conference on Chemicals Management resolution IV/4, the meeting will be conducted in English only.

**Item 3: Development of recommendations for consideration by the fifth session of the International Conference on Chemicals Management for the Strategic Approach and the sound management of chemicals and waste beyond 2020:**

10. Under this agenda item, the meeting will deliberate and finalize recommendations for consideration by the fifth session of the International Conference on Chemicals Management (ICCM5) to be held in Bonn, Germany in the third quarter of 2023.

11. In opening this agenda item, the Secretariat will be invited to present the compilation text for SAICM and the sound management of chemicals and waste beyond 2020 (SAICM/IP.4/2/Rev.1). Document SAICM/IP.4/2/Rev.1 was prepared by the secretariat under the guidance of the intersessional process co-chairs and in consultation with the Bureau of the Conference. In addition, the Secretariat will be invited to present the outcomes of the VWGs 3.

12. Participants may wish to refer to and consider the outcome compilation document SAICM/IP.4/2/Rev.1 as a basis for deliberations at IP4 taking into account the outcomes of the VWGs as presented in SAICM/IP.4/2/Rev.1/Add.1 Outcome of the Virtual Working Group on Targets, Indicators and Milestones, SAICM/IP.4/2/Rev.1/Add.2 Outcome of the Virtual Working Group on Governance and Mechanisms to Support Implementation, SAICM/IP.4/2/Rev.1/Add.3 Outcome of the Virtual Working Group on Issues of Concern and SAICM/IP.4/2/Rev.1/Add.4 Outcome of the Virtual Working Group on Financial Considerations and other submissions from stakeholders so that recommendations may be finalized for consideration at the fifth session of the Conference.

13. To facilitate the discussions on the recommendations, the Bureau at its 20th meeting held in March 2022, requested the Secretariat to prepare a comparison document highlighting the text from three key sources, namely, the current SAICM Overarching Policy Strategy and the SAICM/IP.4/2/Rev.1 Compilation of recommendations regarding the Strategic Approach and the sound management of chemicals and waste beyond 2020 and the outcomes of the 4 Virtual Working Group, in a table format, and presented in SAICM/IP.4/INF/17.

14. A number of working and information documents were prepared for the fourth meeting of the intersessional meeting considering the Strategic Approach and sound management of chemicals and waste beyond 2020 originally scheduled for March 2020. Most of these meeting documents were considered during the Virtual Working Group process, and these are made available on the SAICM website [here](#) as reference documents.
