## Annotations to the provisional agenda

#### Item 1: Opening of the meeting

1. The regional meetings on the Strategic Approach to International Chemicals Management will be opened in a joint plenary session by the President of the fifth session of the International Conference on Chemicals Management (ICCM5), and a representative of the SAICM Secretariat on Thursday, 21 September 2023 at 9.30 a.m.

#### (a) Setting the scene for the resumed IP4 meeting

2. The Co-Chairs of the Intersessional Process will set the scene for the resumed fourth meeting of the Intersessional Process considering the Strategic Approach and sound management of chemicals and waste beyond 2020 that will take place on 23 and 24 September 2023 at the at the World Conference Center Bonn (WCCB) in Bonn.

#### (b) Setting the scene for the ICCM5 meeting

3. The President of the fifth session of the International Conference on Chemicals Management will provide highlights for the fifth Conference of ICCM that will take place in Bonn from 25 to 29 September 2023 at the WCCB in Bonn, with a High-level Segment (HLS) to take place on 28 and 29 September 2023 at a time to be agreed.

#### (c) Substantial and logistic information from the Secretariat

- 4. The Strategic Approach secretariat will provide an overall presentation of the IP4 and ICCM5 documents.
- 5. The Strategic Approach secretariat will present logistic information for the resumed fourth meeting of the Intersessional Process considering the Strategic Approach and sound management of chemicals and waste beyond 2020 and for the fifth session of the International Conference on Chemicals Management.

#### **Item 2: Organizational matters**

- 6. The plenary session of the regional meetings on Thursday, 21 September 2023, as well as regional meetings for the Africa, Asia-Pacific, Central and Eastern Europe and Latin America and Caribbean regions will take place at Rhein Sieg Forum, Bachstraße 1, 53721 Siegburg, Germany.
- 7. On Thursday 21 and Friday 22 September 2023, participants will meet from 9:30 a.m. to 6:00 p.m. with a lunch break and two coffee breaks one in the morning and one in the afternoon,

respectively, in accordance with the tentative programme as set out in Annex 2 to the annotated provisional agenda.

- 8. On Thursday 21 September 2023 a joint plenary session for all regions will take place at 9.30 a.m., and the regions will resume their regional meetings as soon as the joint session is over.
- 9. Regional meetings are expected to be chaired by regional representatives in the ICCM5 Bureau.

This agenda item will be facilitated by the regional representative and participants may wish to share information on activities and initiatives that support the current SAICM objectives taking place within the region.
